What is SMETA 6.1?

The Sedex Members Ethical Trade Audit (SMETA) is a globally recognised and pioneering standard with an audit methodology that provides best practice ethical audit techniques. Developed by Sedex – one of the world's leading ethical trade service providers – audits encompass all four pillars of Sedex's responsible business practice, namely labor, health and safety, environment and business ethics. Two pillar audits are also available against labor and health and safety.

Revised in May 2019, SMETA 6.1 is now GDPR compliant and includes more emphasis on the definition of migrant workers with an option to record worker nationalities as well as a site's GPS location. Auditors are now able to track nationalities of workers from UN sanctioned countries under 'entitlement to work' and in addition, the Worker Wellbeing Assessment has been strengthened.
