TriAge

U.S. employers must verify age and eligibility, but risks remain. The TriAge Framework, developed by LRQA with Fragomen Law and Fortney Scott Attorneys, strengthens verification and controls beyond basic I-9 compliance, with optional third-party validation.

Dignia

Developed in collaboration with major retailers and leading NGO's - including Cierto and The Centre for Child Rights and Business - Dignia combines **confidential worker reporting, expert remediation support, and real-time data insights** to drive transparency, accountability, and measurable impact.

Verified Vendor and Service Provider SAQ's

LRQA's suite of Verified Responsible Sourcing Self-Assessment tools (vSAQ) is designed to **help organizations strengthen supplier oversight** through a flexible, **fit-for-purpose approach tailored** to different partner types—including facilities, service providers, and vendors.
