

# **BC1:2023 Singapore Certification Scheme:**

For Use of alternative structural steel to Eurocode 3

CLIENT INFORMATION NOTE

## What is it?

BC1:2023 is Singapore's national code of practice for use of Alternative Structural Steel materials in BS EN 1993 Design of Steel Structures(Eurocode3). Steel materials not covered in Eurocode3 shall be allowed with our without restrictions as classified in BC1:2023 and only listed materials in Appendix A of BC1 code can be certified by FPC audits by a Conformity Body(CB) accredited by Singapore Accreditation Council(SAC) and will be classified as Class 1 steel materials as defined BC1. LRQA is having accreditation from SAC for certification of Alternative Structural Steel materials as per BC1: 2023

Singapore Accreditation Council - Approval is must for delivering these services. LRQA Limited (Singapore Branch) is accredited by SAC, to conduct FPC audits and and it complies with CT-24 SAC Criteria for Certification Bodies (Alternative Structural Steel in BC1).

When requested by a manufacturer, LRQA shall check whether the manufacture has necessary resources (premises, personnel and equipment) to achieve conformity in production of the structural steel materials. Manufacturer shall demonstrate the conformity of their products to materials as listed in BC1.

#### What we do?

LRQA undertakes FPC assessments as per Product Certification Schemes - ISO/IEC 17065 and CT24 SAC Criteria for Certification Bodies (alternative structural steel in BC1).

Initial audit includes, verifying the product testing carried out as per specified material standard and the result of product testing consistent with the relevant material performance requirements as listed in BC1.

The audit process includes validating the Initial Type Test (ITT) data and assessing Factory Production Control (FPC) management systems for certifying alternative listed steel materials for use in design code. Currently 6 national 's material codes are listed in BC1 (BS EN-Europe, ASTM - America, GB- China, JIS- Japan, AS/NZS-Australia/New Zealand and KS - Korea, for alternative structural steel certifications.

Assessment process comprising a Stage 1 audit to undertake gap analysis, followed by a Stage 2 audit. Stage 1 may be on-site or remote and Stage 2 is based on capability derived from ITT data and for verification of client's order, process inspections, records, and product testing, to meet FPC assessment criteria.

The duration of audits is based on an effective number of workers in the factory including subcontractors under the FPC system, types of steel manufactured, number of locations and the complexity of the processes. Continuous surveillance is required at least once a year. During surveillance LRQA shall check the materials test certificates issued by the manufacturer for compliance to BC1.

An additional surveillance audit may be required if any new production lines are added, considerable change in key personnel, addition of new equipment and any changes to subcontracting scope which was originally assessed.

Certificate suspension will be recommend if any major nonconformities are noticed and a systematic minor nonconformities exist.

The manufacturer's approval certificate is issued for a period of 3 years with continuous surveillance. Change of certification scope, suspension and withdrawal process applies as per the ISO/IEC 17065 product certification scheme and CT24. Renewal of the certificate will go through a repeat audit process to cover all elements of the FPC system to maintain continuity.

LRQA maintains a certified manufacturer's list made available for public views for easy verification. The details include manufacturer's name, plant address, certificate expiry date, products scope audited. Additional information if any, local LRQA office can be contacted for more information.
