What is ASC certification?

The Aquaculture Stewardship Council (ASC) certification is a globally recognized standard for responsibly farmed seafood. It ensures that aquaculture operations adhere to stringent environmental and social criteria, providing assurance to consumers, retailers and businesses that seafood products are sourced sustainably.

What are the benefits of ASC certification?

The ASC is planning to introduce a combined standard, tentatively scheduled for release in May 2025. This new standard aims to integrate various species-specific standards into a single, harmonized framework. The objective is to streamline certification processes, reduce complexity and ensure consistency across different aquaculture operations. By consolidating the standards, the ASC seeks to make it more straightforward for producers to understand and implement the requirements, thereby promoting broader adoption of responsible aquaculture practices.

What does the new ASC combined standard mean for currently certified organizations?

A

Organizations already holding ASC certification will need to transition to the new combined standard once it is officially released. The ASC is expected to outline a transition timeline, providing a grace period for certified entities to align their practices with the updated requirements. This transition will involve retiring the existing species-specific standards and certified organizations will be required to adapt to the unified criteria. Specific dates and guidelines will be communicated by the ASC to ensure a smooth and efficient transition process.
