Gap analysis

Discover how a gap analysis can help you to focus on high risk or weaker areas of your quality management system (QMS) before your certification assessment – so that you can take control and be confident that you are investing time and resources in the right areas of your organisation.

## What is a gap analysis?

During your gap analysis, your LRQA assessor will examine and report on the readiness of your QMS for ISO 9001:2015 certification. You can choose the scope of the analysis to see how your management system addresses or plans to address the requirements in the standard.

## What to expect

- Before your gap analysis visit, we recommend that you familiarise yourself with the standard
- During the gap analysis, your assessor will ask about your understanding of the ISO 9001 requirements and how you plan to implement them into your QMS to ensure compliance
- It is helpful for the assessor to be accompanied by someone from your organisation who understands your QMS and can clarify any points raised
- By identifying any weaknesses in your QMS your assessor will estimate a realistic timescale for your assessment

- You will receive documented commentary that will enable you to plan your next steps
- Based on the findings, your assessor will advise whether your organisation is ready for assessment or will indicate the areas that need attention
- As the gap analysis is not a full assessment against the requirements of ISO 9001:2015 and does not contribute towards certification, we do not issue a certificate at this stage.
