What is ISO 50001?

ISO 50001 is an International Energy Management System (EnMS) standard. Originally published in 2011, it was the first global Energy Management system standard based upon a range of regional and national standards.

ISO 50001 provides organisations with a single, harmonised standard with a logical and consistent methodology for identifying and implementing improvements in energy performance.

ISO 50001 has been designed for implementation by any organisation irrespective of size, sector or geographical location.

The latest version of the ISO 50001 standard was published in August 2018. ISO standards are routinely revised to ensure they stay relevant and meet the changing needs of organisations and their stakeholders.

ISO 50001:2018 brings in a much stronger focus on continual improvement in energy performance with greater involvement of leadership and employees. It uses Annex SL, the common high level structure, which makes it easier to integrate into a common management system.

This helps improve efficiencies and reduce energy costs; thus allowing an organisation to reduce the environmental impact and be more competitive.
