FSMA accredited foreign supplier facility certification

FDA-Recognized Accredited Third-Party Certification from LRQA for Foreign Suppliers to US Importers

The U.S. Food and Drug Administration (FDA) Food Safety Modernization Act (FSMA) aims to ensure the food supply is safe by shifting the focus of federal regulators from responding to contamination to preventing it.

Perhaps one of the most groundbreaking shifts for the FDA is a much stronger focus on import safety, where importers are now responsible for ensuring that their foreign suppliers have adequate preventive controls in place. FSMA regulations require food imported from abroad to be as safe as domestic food.

To support this requirement, the FDA FSMA rule on Accredited Third-Party Certification has been finalized, and the program is now open for participation. The rule establishes a voluntary program for the accreditation of third-party certification bodies, like LRQA, to conduct food safety audits and issue certifications of foreign entities, including farms, under section 806(d) of FSMA. LRQA is working towards FDA-recognized accreditation to deliver Consultative Audits, Regulatory Audits and Accredited Third-Party Certification under FSMA. FSMA certifications issued under the US FDA accredited third-party certification program are used:

- By US importers that will use certifications of foreign suppliers, including farms, to help establish their eligibility to participate in the Voluntary Qualified Importer Program (VQIP), which is a voluntary program that provides for the expedited entry of food imported by participating importers.
- For supplier verification activities under the Preventive Controls for Human Food Rules, Preventive Controls for Animal Food Rules, and Produce Safety rules.
- When required by FDA as a condition of entry. For example:
 - safety risks associated with the food product,
 - food safety risks associated with the country, region, or origin of the food, and
 - the capability of the regulatory system of the exporting nation to ensure compliance with FDA safety standards.

What is Accredited FSMA Foreign Supplier Facility Certification?

Under section 806(d) of FSMA, U.S. importers must have a facility certification issued consistent with section 808 of the FD&C Act regarding accreditation of third-party certification bodies, also known as auditors, for each foreign supplier's facility from which they want to import a food under VQIP. The foreign supplier's facility must have a facility certification, which would be issued following a regulatory audit conducted by an accredited third-party certification body that is accredited under FDA's third-party certification regulations (see 21 CFR 1.653). Either the U.S. importer or the foreign supplier may request the regulatory audit required for facility certification.



An FDA inspection of the foreign supplier would not meet the requirement under section 806(d) of FSMA because an FDA inspection does not result in a facility certification consistent with the requirements of FSMA regulations.

What is the difference between Facility Certification and a Regulatory Audit under FSMA?

A facility certification is an attestation issued by an accredited third party certification body after conducting a regulatory audit and any other activities necessary to establish whether a facility complies with the applicable food safety requirements of FSMA and FDA regulations; any food the importer wishes to be covered under VQIP should be within the scope of the facility certification.

A regulatory audit, for purposes of VQIP, is an audit of a foreign supplier's facility by an accredited third-party certification body, such as LRQA, in accordance with FDA's third- party certification regulation. The results of the audit are used to determine whether a foreign supplier is eligible for a facility certification.

How often must a foreign supplier's facility be recertified?

Under FSMA regulations, the foreign supplier of a VQIP must obtain recertification annually, and allows accredited certification bodies, such as LRQA, to issue a certification for a term of up to 1 year. Although it is anticipated that most foreign supplier facility certifications will have a term of 1 year, the certification body may find it appropriate in some circumstances to issue the certification for a shorter term and may require the facility to be reaudited and re-certified more frequently (for example, when there are multiple seasonable productions during a year).

Why is Accredited Foreign Supplier Facility Certification under FSMA VQIP Important?

LRQA issued accredited FSMA certifications under the U.S. Food and Drug Administration (FDA) third-party program may be used:

- By importers for establishing eligibility of foreign suppliers for expedited review of food entry in the United States.
- For supplier verification activities under the Food Safety Verification Program and Preventive Controls rules.
- When required by the FDA as a condition of entry under specific circumstances related to safety risks.
- To determine if an organization is in compliance with applicable U.S. food safety requirements as well as with industry standards and practices.
- To determine if facilities are complying with applicable food safety requirements under the FD&C Act and FDA FSMA regulations.

If you're a foreign supplier into the US, FSMA accredited third party certification under the FDA program can add market and competitive advantage for your organization.

What types of organizations should pursue Accredited Foreign Supplier Certification under FSMA?

All foreign supplier facilities that want to be able to demonstrate their commitment to FSMA and to U.S. food importers should acquire accredited Foreign Supplier Facility Certification to help build credibility and trust that an independent set of food safety expert eyes are helping to assure your organization is fulfilling its responsibilities under FSMA. In addition, if you know or anticipate the U.S. importer in which your foreign facility supplies may seek participation in VQIP under FSMA, as a foreign facility, you are encouraged to be proactive and obtain accredited foreign facility certification from LRQA.

What if my facility is already certified to HACCP or a GFSI recognized standard, including FSSC 22000 or BRCGS?

If your facility is already certified to HACCP or a GFSI-recognized food safety standard, your FDA-recognized accredited Foreign Supplier Facility Certification can be added to your existing certification assessment.
