# Palm Oil

---

Palm oil is the most commonly used vegetable oil globally, with estimates from the WWF indicating that it is present in almost 50% of all packaged products readily available in supermarkets. It is used in various products, including bakery items, processed foods, chocolate, personal care products, cosmetics, shampoos, and many other things. Due to its unique properties, it is difficult to substitute with other oils. One hectare of palm plantation can produce up to eight times more yield than comparable oils such as rapeseed, sunflower and soya.

## Impact and Sustainability

The increase in global demand for palm oil has led to the expansion of palm oil plantations, this has caused and continues to cause deforestation which creates an adverse impact on biodiversity and the management of primary forests. The expansion of palm oil implantation has also led to the displacement of local communities and the economic exploitation of workers' rights to fair pay and acceptable welfare standards. However, when grown sustainably, palm oil production has many benefits, including safeguarding of the environment, local communities, employees, and wildlife. Promoting sustainable palm oil practices helps to ensure these positive impacts are maximised.

Research indicates that consumer behaviour is changing, and individuals are becoming more ethically driven. Stakeholder pressure is driving organisations to do more to demonstrate their commitment to minimising the environmental and social impact of their operations. The changing dynamic is resulting in a greater focus on sustainability across the global food supply chain.

## Regulatory pressure

The European Commission has implemented Regulation EU 2021/ 1119, known as the EU Climate Law. By the end of 2023, the Commission will introduce a legislative proposal for a sustainable EU food system that will apply to all actors in the supply chain operating in or supplying into the EU market. This decision is expected to impact the commercial practices of organisations in other global markets as the EU is the largest global market for agri-food products, and there is a commitment to encourage other nations to adopt similar practices.

The Roundtable on Sustainable Palm Oil (RSPO) is a trade body that has established a set of economic and social criteria that companies must adhere to in order to produce and source Certified Sustainable Palm Oil (CSPO). The RSPO was formed by a group of stakeholders, including palm oil producers, processors, traders, consumer goods manufacturers, retailers, banks, and NGOs, who recognised the need for a global platform to promote the production and use of sustainable palm oil.

The RSPO's mission is to encourage the growth and use of sustainable palm oil by promoting sustainable practices in the production of palm oil, supporting the development of sustainable supply chains, and raising awareness among consumers about the importance of sustainable palm oil.

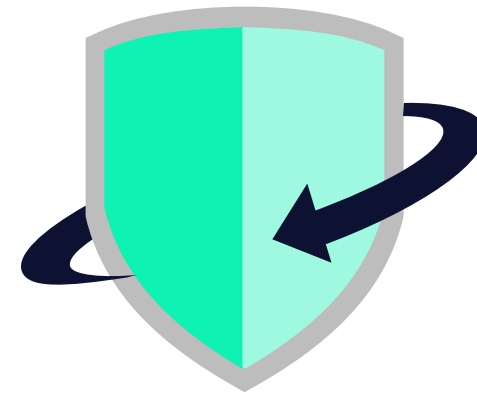
