## Gap analysis - At a glance

LRQA's gap analysis assessment examines and reports on your management systems' readiness for certification. We focus on how your management system has addressed, or plans to address, the AS standard(s) requirements and identify any critical, high-risk or vulnerable areas of your management system.

Based upon the findings, your assessor will advise whether your organisation is 'likely, partially likely or unlikely' to meet the new standard requirements.

## Preparing for the gap analysis visit

In advance of the gap analysis visit, you should familiarise yourself with the applicable AS standard requirements. During the visit your assessor will ask you a set of thorough questions that will determine your understanding of the standard(s) and how you have implemented these into your management system.

# Do I get a report after the gap analysis?

After the assessment you are issued with a report outlining recommendations for improvements in line with the applicable AS standard(s) processes and requirements. This enables you to plan your next steps for achieving certification.

Any 'gaps', especially where the response is 'partial' or 'unlikely', are clearly identified and your assessor will discuss how these gaps may be addressed to demonstrate compliance.

 Please note that a gap analysis visit is not a full certification assessment against the standard requirements and a certificate cannot be issued.

Assessments are conducted in accordance with AS 9104-001, the global IAQG certification scheme, which applies to aerospace products and services, where the duration of your assessment will depend on the certification structure, number of employees and complexity of the management system.

LRQA's trained and qualified assessors have been authenticated by the aerospace industry and registered on the IAQG OASIS database. They apply assessment methods defined in AS 9101F producing reports, which are entered onto the IAQG OASIS database.

The OASIS database is an online resource that contains a list of organisations who are certified and registered under the IAQG rules, which demonstrates they comply with the aerospace quality management system requirements.
