## Terms and conditions of use


#### Using the mark

You can use the relevant LRQA partner mark on your stationery, publicity material, company buildings, flags, vehicles, and so on. It can be reproduced in any single colour and at a size that is clearly legible. We provide a full colour version of the marks with a CMYK variation for use on printed materials and an RGB variation for use on screen. This ensures the optimal display of your mark. The marks come in portrait and landscape format.

#### If the mark changes

If the LRQA marks change, you will be notified by your local LRQA office. Please update to the new mark at your earliest convenience. Ideally, this would take place in line with your next certificate renewal visit. Your company can continue to use the previous LRQA mark for a reasonable time. Please contact your local LRQA client services team, who will be happy to assist you in updating to the current approval mark.

The Farm Fist marks can be used if you have obtained Farm First certification. The Farm First mark is also available with the scheme grading information, e.g. Silver, Gold or Platinum.

# Terms and conditions of use

#### Using the mark

LRQA partner marks don't demonstrate product or service approval so marks can't be used on the product itself or on the product packaging. This excludes the Farm First mark, which can be used on product packaging, however, the mark must only be used on products within your Farm First certificates remit. For example, if you receive Farm First certification for poultry products, the mark may be used on poultry product packaging, but should not be used on other animal product packaging.

You cannot use the relevant LRQA partner mark on test or calibration reports, certificates or on certificates of conformity.

The mark must not imply that certification exists other than as defined in the LRQA scope and at the location(s) printed on your certificate.

Statement of Certification

A statement of certification can be applied on product packaging (that can be removed without the product disintegrating or being damaged) or accompanying information (considered as separately available or easily detachable) to demonstrate that you have received assurance services from LRQA. Type labels or identification plates are considered as part of the product.

The statement shall include reference to;

- Identification (e.g. brand or name)
- The type of management system and the applicable standard
- LRQA as the certifying body.

Correct use of your mark and statement of certification, is a contractual obligation. LRQA monitors the use of the mark and statements of certification during surveillance and certificate renewal visits. By using the LRQA partner mark(s), you are agreeing to follow the terms of use.

### **Farm First marks**

### **Farm First** mark

#### Mark types

There are two basic types of LRQA Farm First marks available. Base Farm First marks and Farm First Approval marks.

The basic farm first mark should be used to indicate the LRQA Farm First scheme is in use whereas the Approval mark is used to denote which level (Gold, Silver or Platinum) has been achieved.

#### Minimum size

#### **Packaging Companies**

Once certification is achieved, packaging companies will be supplied with a link to download the relevant artwork for the Approval mark to be affixed during the packaging process.

The Approval mark should be applied in a prominent position on the front of pack where possible.





Using our marks consistently is a key part of creating a coherent brand.

On this page, you'll see a few common mistakes to avoid when using the LRQA marks in any of their variations.

Avoid the following

Compressing the mark, either vertically or horizontally.

Using an incomplete version of the mark.

Display a rotated version of the mark.




Include additional wording on the mark.



Adjust the colours of the mark.



Re-order elements

Adjust any graphic elements that make up the mark.



Apply the mark on a none-contrasting background.
