

amfori BSCI (social compliance)

The Business Social Compliance Initiative (BSCI) is a leading audit methodology that supports businesses in driving social compliance and improvements within the factories and farms throughout their global supply chains. A BSCI audit is a comprehensive evaluation of adherence to social compliance standards including workers' rights, fair pay, occupational health and safety, and more.

With amfori BCSI, audit data is shared with all participants on one BCSI database, reducing the time and cost of sharing information.

Social and Labour Convergence Program (SLCP)

The Social Labor Convergence Program (SLCP) is a multistakeholder initiative with an overall goal of improving working conditions by providing the tools to capture supply chain data globally. Wanting to increase collaboration across the apparel and footwear industry, the SLCP has developed the Converged Assessment Framework (CAF), a common data tool and verification methodology. Together they provide the tools to produce a set of verified data on social and labour conditions in facilities.

By choosing SLCP your facilities can share this verified data with their stakeholders and replace the need for repetitive social audits.

Initiative for Compliance and Sustainability (ICS)

Initiative for Compliance and Sustainability (ICS) is a member based initiative with the aim of enhancing working conditions in factories operating in the textile, retail, footwear, electronics and furniture sectors. ICS offers retailers and brand members with common collaboration tools to share knowledge and reduce 'audit fatigue'. Uniquely, ICS audits are mandated and managed by members, which ensures total control of the use of ICS tools.

Completing an ICS audit not only provides full transparency across your supply chain but utilises a common methodology and framework defined by the International Labour Organization (ILO) conventions.

RBA-VAP

Responsible Business Alliance – Validated Assessment Program (VAP) methodology is based on the RBA Code of Conduct, a set of social, environmental and ethical industry protocols. A typical VAP onsite audit at a single manufacturing facility may last 2-5 days and includes a thorough document review, interviews with stakeholders and a visual site survey.

There is also a VAP Recognition Programme, that recognises those that demonstrate their commitment to corporate responsibility. The programme offers three levels platinum, gold and silver, which is dependent on the VAP score.

RSPO

The Roundtable on Sustainable Palm Oil's mission is to promote the growth and use of sustainable palm oil, which is produced in an environmentally and socially responsible manner by developing and implementing global standards for the production and use of sustainable palm oil. These standards are based on principles and criteria covering a range of social, environmental, and economic issues related to palm oil production. The RSPO also provides a certification scheme for palm oil producers who comply with these standards.
