# Sahyadri Farms: Ensuring food safety matches global standards

LRQA's auditors helped Sahyadri Farms to dramatically improve their approach towards Food Safety Management Systems, begin operating on a global scale, and secure long-term growth potential with FSSC 22000 standards.

#### 02. Key facts:

In India, there's a subsect of farmers who grow fruits and vegetables on less than 1 ha. of land. They are known as 'marginal farmers', and while they grow their produce on a small scale, they collectively make up around 83% of the country's farming industry.

Sahyadri Farms is a farming collective that aims to bring these farmers together and provide them with export access to global food supply chains.

#### 03. Result:

Since the completion of their audit and certification FSSC 22000, Sahyadri Farms has reported a 90% reduction in customer complaints, a major improvement in Product Safety and an increase in performance efficiency of 25%. 10550+ farmers are currently registered as a producer with Sahyadri Farms. The challenge was, as Sahyadri Farms grew in strength, the business matured so did the need to certify to Global Food Safety Initiative (GFSI) recognised standards and schemes that potential clients would expect. LRQA speaks with Shrikant Kulkarni, General Manager – Operations at Sahyadri Farmers Producer Co. Ltd, to discuss the FSSC 22000 certification process and how it has helped the team manage food safety risks against a global backdrop.

## A strategic priority

The food safety management system (FSMS), FSSC 22000, enables Sahyadri Farms to operate on a global scale and also continue to make farming sustainable and profitable for its farmer members.

### Managing international standards with homegrown produce and small farmers

Shrikant and the team at Sahyadri were confident in their food safety and quality but as the company grew and geared up for global customers, they realised it was very important for them to implement an international standard like FSSC 22000.

The audit process involved a single location in Nashik, Maharashtra, and 350 people were involved, including Sahyadri employees and expert auditors from LRQA. Following certification to FSSC 22000, Sahyadri has reported a complete shift towards a more quality-driven mindset where all employees started following continual improvement practices for their systems and processes. In just five years, Sahyadri Farms has scaled from revenue figures of 0.5 billion INR to 5 billion INR. Since the completion of their audit and certification FSSC 22000, Sahyadri Farms has reported a 90% reduction in customer complaints, a major improvement in Product Safety and an increase in performance efficiency of 25%.

### Sahyadri Farms and LRQA
