



# Environmental Policy GMS01-04

## Purpose and Application

LRQA operates to the highest ethical and sustainability standards, and we are committed to minimising the environmental impacts of our business operations and to maintain resilience to environmental risks and impacts.

Our Environmental Policy applies to all our colleagues, anyone doing business for/with LRQA, and others acting on our behalf.

## 1. LRQA's commitment

- 1.1. LRQA is committed to improving our environmental performance by setting targets and monitoring progress. We strive to prevent pollution, minimise waste, be efficient in our energy, water and resource use, reduce our overall impact on the environment and to become a net zero business by no later than 2030.
- 1.2. Our key principles include:
  - 1.2.1. We comply with all applicable laws and regulations relating to environmental sustainability practices and disclosures;
  - 1.2.2. We set clear environmental sustainability objectives and monitor progress toward them;
  - 1.2.3. We are transparent about our carbon footprint and greenhouse gas emissions;
  - 1.2.4. We undertake waste audits/environmental audits to support minimising our environmental impacts;
  - 1.2.5. We promote improved environmental management and resilience practices to our colleagues, suppliers and other business partners.
- 1.3. LRQA colleagues must be mindful of the environmental impacts of their work, and seek to reduce or mitigate those impacts as far as practicable.

## 2. Our Planet, Our Plan
